

## **SAMSUNG BUY MORE SAVE MORE OFFER TERMS AND CONDITIONS**

**Offer description.** Purchase two (2) or more eligible Samsung products from eligible categories that include Mobile & Wearables (Smartphones, Watches, Tablets), Home Entertainment (TV), Home Appliance (Dishwasher, Refrigerator, Range, Cooktop, Wall Ovens, Jet Stick Vacuums) or Computing (Laptops, Monitors) (see Appendix for list of eligible products) from a participating retailer and receive a Samsung Prepaid Mastercard® in the amount of 10% off the pre-tax purchase price of the product. All purchases must include products from two (2) or more different product categories (“Qualifying Purchase”). Available at all participating authorized retailers.
